Pet Health Warranty Contract

This Pet Health Warranty Contract ("Contract") is provided by the Pet Dealer and is NOT INSURANCE. The Contract is by and between the Pet Dealer and the Consumer and complies with the New Jersey State Law governing the sale of puppies; a copy of the Notification of Consumer Rights ("NCR") will accompany this Contract.

Any conditions listed in the above Pre-existing Condition section will be an exclusion from this Contract. All warranties contained herein are non-transferable and valid to the original purchaser only. The puppy you have purchased is sold to you as a companion pet only: Pet Dealer cannot guarantee the puppy for the purpose of breeding or showing, or guarantee the size, weight or other breed characteristics of the adult dog.

SELECTION OF OPTIONS

- 1. Return my animal and receive a refund of the purchase price, including sales tax, plus reimbursement of applicable veterinary fees incurred prior to the date I received my veterinarian's certification of unfitness pursuant to the NCR.
- 2. Keep my animal and receive reimbursement of applicable veterinary fees incurred pursuant to the NCR
- 3. Return and exchange my animal for another animal of my choice of equal value and receive reimbursement of applicable veterinary fees pursuant to the NCR.

In the event of the death of the animal, I am to receive a full refund of the purchase price, including tax, or an exchange for another animal of my choice of equal value plus reimbursement of applicable veterinary fees pursuant to the NCR.
